

RESOLUTION NO. 2012-01-08

CONCERNING THE ISSUANCE OF SPECIAL EVENT PERMITS BY THE LOCAL LICENSING AUTHORITY

WHEREAS, the City Council of the City of Fort Morgan acts in the capacity of the Local Licensing Authority regarding the issuance and regulation of liquor licenses and related permits; and,

WHEREAS, the Colorado General Assembly adopted Senate Bill 11-066, which was signed into law and became effective Aug. 10, 2011, and which allows local licensing authorities to choose to assume sole authority to approve or deny applications for special event permits to serve alcohol without obtaining the state licensing authority's approval or disapproval; and,

WHEREAS, choosing to implement local approval of special event permits will streamline the process and lower the cost of applying for special event permits for applicants; and,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1: Pursuant to C.R.S. 12-48-107(5)(a), as amended by Senate Bill 11-066, the Local Licensing Authority of the City of Fort Morgan elects not to notify the state licensing authority to obtain the state licensing authority's approval or disapproval for a special event permit.

SECTION 2: When exercising the administrative duties associated with an application for a special event permit, the City Clerk, acting as the Secretary of the Local Licensing Authority, shall comply with the requirements of C.R.S. 12-48-107(5), and perform all actions required of the Local Licensing Authority by said statute.

SECTION 3: Upon receipt of an application for a special event permit, the City Clerk shall access information made available on the web site of the state licensing authority to determine the statewide permitting activity of the organization applying for a permit, and consider compliance with the provisions of C.R.S. 12-48-105(3) limiting to fifteen (15) the total number of days for special event permits in any one year for any one organization before processing any application.
