

## **RESOLUTION NO. 09 06 05**

### **AUTHORIZING THE MAYOR TO EXECUTE THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF FORT MORGAN AND COUNTY OF MORGAN FOR THE ALLOCATION OF THE JUSTICE ASSISTANCE GRANT PROGRAM AWARD**

**WHEREAS**, this Agreement is made under the authority of CRS 29-1-203; and,

**WHEREAS**, each governing body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and,

**WHEREAS**, this JAG is contingent upon the acceptance and allocation of the award between the CITY and COUNTY; and,

**WHEREAS**, the CITY and COUNTY believe it to be in their best interests to reallocate the JAG funds available for law enforcement purposes; and,

**WHEREAS**, each governing body finds that the performance of this Agreement is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

**WHEREAS**, the CITY shall be using \$8,124.50 for the purchase of ballistic helmets that will provide added safety for the Fort Morgan Police Department for "Rapid Response" incidents; and,

**WHEREAS**, the CITY agrees to provide the COUNTY with \$8,124.50 from the JAG award for their patrol deputies to purchase "Rapid Response" equipment.

**WHEREAS**, the City Police Department has recommended the execution of **Intergovernmental Agreement Between the City of Fort Morgan and County of Morgan, Colorado: Justice Assistance Grant (Jag) Program Award** of which is attached hereto and incorporated herein by this reference.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SEC. 1:** The Mayor is hereby authorized to execute the **Intergovernmental Agreement Between the City of Fort Morgan and County of Morgan, Colorado: Justice Assistance Grant (Jag) Program Award**.
