AMENDING THE 2013 SCHEDULE OF FEES

WHEREAS, the City of Fort Morgan operates a public library; and,

WHEREAS, the State of Colorado offers grants and other funding to public libraries throughout Colorado; and,

WHEREAS, the State maintains certain requirements in order to a public library to receive grant funding; and,

WHEREAS, in order for the Fort Morgan Library to participate in certain State funding, adjustments need to be made to the current fee schedule.

Research requests are to be submitted in writing via on-line form available on the city's website. Research includes three (3) B & W photocopies. Use and reproduction fees apply.	\$15.00/HR Minimum ½ hour charged

Visitors to the Bloedorn Research Center – First two (2) hours are free. Walk in researchers and non-scheduled research requests. Use and reproduction fees apply.




