

RESOLUTION NO. 2013-12-01

A RESOLUTION RATIFYING THE EMERGENCY PURCHASE FOR FLOOD RECOVERY

WHEREAS, the City of Fort Morgan recently experienced flooding in the South Platte River; and,

WHEREAS, Chapter 2 Article 8 of the Fort Morgan Municipal Code defines an “Emergency” as “any event that poses an immediate danger to life, property and well-being of City citizens, economy, environment and community”; and,

WHEREAS, under Chapter 2 Article 8, the Mayor has authority to declare an emergency for purposes of the emergency management and operations of the City, which was done on September 15, 2013; and,

WHEREAS, the procurement policy of the City of Fort Morgan, per Chapter 4 Article 6 Section 50, allows the Mayor to authorize expenditures for emergency purchases; and,

WHEREAS, the procurement policy of the City of Fort Morgan requires that any emergency purchases in excess of \$10,000 be ratified by the City Council; and,

WHEREAS, the City has contracted with BluSky Restoration Contractors for restoration work at Riverside Park as a result of the flood emergency; and,

WHEREAS, the restoration services will be in excess of \$10,000, thus requiring City Council ratification.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1: The Mayor’s emergency authorization of restoration work at Riverside Park by BluSky Restoration Contractors is hereby ratified and made effective by the City Council of the City of Fort Morgan.
