

RESOLUTION NO. 2014-04-03

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN COMMUNITY RESOURCES AND HOUSING DEVELOPMENT CORPORATION AND CENTENNIAL MENTAL HEALTH

WHEREAS, the Community Resources and Housing Development Corporation has recently acquired land on which to build a multifamily housing unit; and,

WHEREAS, a portion of the property abuts a dedicated right of way in which is located public infrastructure and which is designated to be developed into Linda Street; and,

WHEREAS, property owners next to the dedicated right of way are required to proportionately share in the costs of developing Linda Street; and,

WHEREAS, each party to this agreement has, or will have, property adjacent to the required street development; and,

WHEREAS, the attached memorandum of understanding addresses the responsibilities of the parties for the design and engineering of Linda Street; and,

WHEREAS, the Agreement requires the Mayor's signature and the Council's Authorization.

NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. The City of Fort Morgan hereby authorizes the Mayor to sign the Memorandum of Understanding between the Community Resources and Housing Development Corporation, Centennial Mental Health, and the City of Fort Morgan and authorizes the expenditure of the funds associated therewith.
