

RESOLUTION NO. 2014-05-05

A RESOLUTION RATIFYING THE EMERGENCY PURCHASE FOR PRESSURE REDUCING VALVES

WHEREAS, on September 6, 2013 the City of Fort Morgan water distribution system experienced an uncontrolled and unexpected surge of pressure which ruptured several water distribution lines as the result of a Pressure Reducing Value (PRV) failure; and,

WHEREAS, the Procurement Policy of the City of Fort Morgan, Municipal Code § 4-6-50(b), allows for emergency purchases when “the life, health or safety of employees or the general public is at risk or when significant harm may occur to operating systems”; and,

WHEREAS, the procurement policy of the City of Fort Morgan allows the Mayor to authorize expenditures over \$10,000 for emergency purchases; and,

WHEREAS, the procurement policy of the City of Fort Morgan requires that any emergency purchases in excess of \$10,000 be ratified by the City Council; and,

WHEREAS, the City has contracted for the replacement of the PRV and recently purchased the PRV as a result of the September 6, 2013 incident; and,

WHEREAS, the PRV will be in excess of \$10,000, thus requiring City Council Ratification.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1: The purchase of the replacement PRV in an amount not to exceed \$49,293.27 is hereby ratified and made effective by the City Council of the City of Fort Morgan.
