

RESOLUTION NO. 2015-02-05

INCREASING THE WASTEWATER TREATMENT PLANT INVESTMENT FEES FOR THE CITY OF FORT MORGAN, COLORADO

WHEREAS, the projected revenues of the wastewater rate study were completed in 2014, by Farnsworth Group; and,

WHEREAS, plant investment fees are a one-time capital charge for all new customers of the city and are used to reduce the burden to existing customers for financing new growth; and,

WHEREAS, the system by-in method is based on the premise that new customers are entitled to service at the same prices charged to existing customers, and,

WHEREAS, the net equity per wastewater tap for the total wastewater system ranges between \$3,455 and \$10,789; and,

WHEREAS, the 2014 rate study recommends increasing the wastewater plant investment fees according to the net equity per wastewater tap; and,

WHEREAS, an increase in the wastewater treatment plant investment fees would create additional revenue within the Wastewater Enterprise Fund to allow for future infrastructure improvements and major expansions that will benefit the customers; and,

WHEREAS, pursuant to Section 18-3-10 of the *Fort Morgan Municipal Code* all wastewater rents, rates and charges payable within the City are to be established by Resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Effective February 3, 2015, the City hereby adopts the Wastewater Treatment Plant Investment Fees (attached hereto as Exhibit A).


