

ORDINANCE NO. 1171

AN ORDINANCE ANNEXING TO THE CITY OF FORT MORGAN THAT AREA KNOWN AS THE FM ACOMA I ANNEXATION AS DESCRIBED HEREIN

WHEREAS, the City Council of the City of Fort Morgan on February 17, 2015, adopted a resolution finding that the FM Acoma I Annexation petition for annexation was in substantial compliance with C.R.S. §31-12-107, and set a hearing date of April 7, 2015, for the Fort Morgan City Council to consider the annexation of the area set forth below; and

WHEREAS, pursuant to the notice required under C.R.S. §31-12-108, the Municipal Annexation Act of 1965 as amended, hereinafter referred to as the Annexation Act, the City Council of Fort Morgan held on April 7, 2015 a hearing pertaining to said annexation; and

WHEREAS, owners of one hundred percent (100%) of the area have petitioned for such annexation; and

WHEREAS, the City Council of the City of Fort Morgan has by resolution made findings of fact and conclusions of law based thereon and determinations pertaining to said annexation, and has determined said area should be annexed forthwith as part of the City of Fort Morgan.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. The following described territory is hereby annexed to and made a part of the City of Fort Morgan, Colorado:

A PARCEL OF LAND LOCATED IN THE NORTHWEST ONE-QUARTER OF SECTION 7, TOWNSHIP 3 NORTH, RANGE 57 WEST OF THE 6TH PRINCIPAL MERIDIAN, COUNTY OF MORGAN, STATE OF COLORADO, MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT A POINT ON THE SOUTH LINE OF THE NORTHWEST ONE-QUARTER OF SAID SECTION 7, WHENCE THE CENTER ONE-QUARTER CORNER OF SAID SECTION 7 BEARS N 88° 59' 33" E, 974.00 FEET FORMING THE BASIS OF BEARING USED IN THIS DESCRIPTION WITH ALL BEARINGS SHOWN HEREON RELATIVE THERETO. ALONG THE SOUTHEASTERLY PROLONGATION OF THE SOUTHWESTERLY LINE OF THE SUBDIVISION EXEMPTION PLAT, RECORDED AT LAND SURVEY PLAT BOOK 6, PAGE 43, TO THE SOUTHWEST CORNER OF SAID SUBDIVISION EXEMPTION PLAT AND THE POINT OF BEGINNING N 18° 44' 45" W, 31.34 FEET;

THENCE ALONG THE SOUTHWESTERLY PROLONGATION OF THE SOUTH LINE OF SAID SUBDIVISION EXEMPTION PLAT TO THE EAST LINE OF THE FORT MORGAN MIDDLE SCHOOL ANNEXATION PLAT (RECEPTION NUMBER 1500331) S 71° 25' 26" W, 42.67 FEET;

THENCE ALONG THE SAID EAST LINE TO THE SOUTHWESTERLY PROLONGATION OF THE NORTH LINE OF SAID SUBDIVISION EXEMPTION PLAT N 13° 37' 28" W, 80.30 FEET;

THENCE ALONG THE SOUTHWESTERLY PROLONGATION OF THE NORTH LINE OF SAID SUBDIVISION EXEMPTION PLAT THROUGH THE NORTHWEST CORNER OF SAID SUBDIVISION EXEMPTION PLAT AND CONTINUING ALONG THE NORTH LINE OF SAID SUBDIVISION EXEMPTION PLAT N 71° 25' 26" E, FOR A TOTAL DISTANCE OF 85.00 FEET;

THENCE DEPARTING SAID NORTH LINE, ALONG THE FOLLOWING FIVE (5) COURSES;

- 1) S 18° 34' 34" E, 30.00 FEET;
- 2) S 71° 25' 26" W, 74.93 FEET;
- 3) S 18° 34' 34" E, 20.00 FEET;
- 4) N 71° 25' 26" E, 71.00 FEET;
- 5) TO THE SOUTH LINE OF SAID SUBDIVISION EXEMPTION PLAT S 18° 34' 34" E, 30.00 FEET;

THENCE ALONG THE SAID SOUTH LINE S 71° 25' 26" W, 45.33 FEET TO THE POINT OF BEGINNING.

CONTAINING AN AREA OF 5,461 SQ. FT. OR 0.13 ACRES, MORE OR LESS.

SECTION 2. When this annexation is complete, said area shall become a part of the City of Fort Morgan for all intents and purposes on the effective date of this ordinance, with the exception of general taxation, in which respect said annexation shall not be effective until on or after January 1 next ensuing.

SECTION 3. The City Clerk shall be, and is hereby authorized and directed to file an original copy of this **Ordinance** and one copy of the **Map of Annexation** in the office of the City Clerk of the City of Fort Morgan, Colorado, and two certified copies of said **Ordinance** and **Map of Annexation** in the office of the Clerk and Recorder of Morgan County, Colorado.

SECTION 4. The ordinance shall be in full force and effect from and after its passage and publication as provided by the City Charter.


