

RESOLUTION NO. 2015-06-01

A RESOLUTION RATIFYING THE EMERGENCY EXPENDITURES FOR WATER TREATMENT BACKUP GENERATORS

WHEREAS, the City of Fort Morgan water treatment plant recently experienced a power outage in connection with heavy rain and flooding in Morgan County in May of 2015; and,

WHEREAS, the backup generator on site experienced a failure necessitating the immediate rental of an additional backup generator to ensure uninterrupted water treatment for the City; and,

WHEREAS, under Chapter 2 Article 8 of the Fort Morgan Municipal Code, the Mayor has authority to declare an emergency for purposes of the emergency management and operations of the City; and,

WHEREAS, the procurement policy of the City of Fort Morgan, per Chapter 4 Article 6 Section 50, allows the Mayor to authorize expenditures for emergency purchases; and,

WHEREAS, the procurement policy of the City of Fort Morgan, requires that any emergency purchases in excess of \$10,000 be ratified by the City Council; and,

WHEREAS, the City contracted with Cummins Rocky Mountain for rental of a backup generator and repairs to the backup generator owned by the City; and,

WHEREAS, the total cost for services will be in excess of \$10,000, thus requiring City Council Ratification.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1: The contract between Cummins Rocky Mountain and the City of Fort Morgan for rental of a generator and repair work at the City of Fort Morgan Water Treatment Plant is hereby ratified and made effective by the City Council of the City of Fort Morgan.


