

RESOLUTION NO. 2015-06-06

A RESOLUTION RATIFYING THE EMERGENCY EXPENDITURES FOR STORM WATER SYSTEM REPAIRS

WHEREAS, the City of Fort Morgan storm water system recently experienced several pipe failures caused by the extreme storm events which brought record rainfall and flooding to Morgan County in May 2015; and,

WHEREAS, upon inspection of the system it was discovered that several sinkholes and pipe failures are along the system utilized by the Fort Morgan Industrial Park that required immediate repair; and,

WHEREAS, under Chapter 2 Article 8 of the Fort Morgan Municipal Code, the Mayor has authority to declare an emergency for purposes of the emergency management and operations of the City; and,

WHEREAS, the procurement policy of the City of Fort Morgan, per Chapter 4 Article 6 Section 50, allows the Mayor to authorize expenditures for emergency purchases; and,

WHEREAS, the procurement policy of the City of Fort Morgan requires that any emergency purchases in excess of \$10,000 be ratified by the City Council; and,

WHEREAS, the City has purchased 48-inch corrugated pipe, manholes and associated materials from Big R Bridge for replacement and repairs to the storm system owned by the City; and,

WHEREAS, the City contracted with the 2015 On-Call Wet Utility Repair and Excavating contractor, Ransom Boone Excavating, for replacement and repairs to the storm system owned by the City;

WHEREAS, the total cost for services will be in excess of \$10,000, thus requiring City Council Ratification.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1: The contract between Ransom Boone Excavating, material purchases from Big R Bridge and the City of Fort Morgan for replacement and repair work on the City of Fort Morgan storm water line from the Fort Morgan Industrial Park is hereby ratified and made effective by the City Council of the City of Fort Morgan.

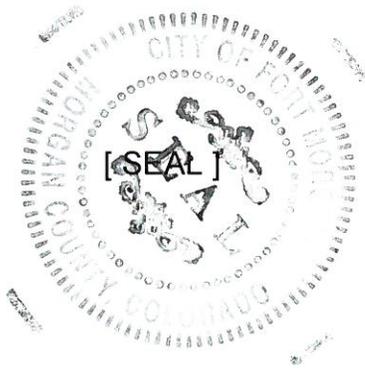
