

RESOLUTION NO. 2015-07-02

AUTHORIZING THE MAYOR TO EXECUTE AGREEMENTS BETWEEN THE CITY OF FORT MORGAN AND COLORADO INTERSTATE GAS COMPANY FOR GAS DELIVERY AND STORAGE

WHEREAS, the City of Fort Morgan and Colorado Interstate Gas Company ("CIG") have previously entered into Agreements for storage and transportation delivery service for natural gas utilized by the City effective on May 1, 2012; and,

WHEREAS, these Agreements require the rate schedules contained therein to be modified and updated; and,

WHEREAS, the City and CIG have determined the terms contained in Agreement No. 31039000-NNT2CIG and Agreement 38007000-TF4CIG are acceptable to both parties.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SEC. 1: The Mayor is hereby authorized to execute the No-Notice Storage and Transportation Delivery Service Agreement Rate Schedule NNT-2 (Agreement No. 31039000-NNT2CIG) between the City of Fort Morgan and Colorado Interstate Gas Company, LLC.

SEC. 2: The Mayor is hereby authorized to execute the Transportation Service Agreement Rate Schedule TF-4 (Agreement 38007000-TF4CIG) between the City of Fort Morgan and Colorado Interstate Gas Company, LLC.
