

ORDINANCE NO. 1177

AN ORDINANCE ESTABLISHING A NEW CITY DEPARTMENT CALLED THE ECONOMIC DEVELOPMENT AND MARKETING DEPARTMENT

WHEREAS, the City of Fort Morgan adopted an economic development strategic plan in 2014 with specific goals and program development initiatives; and

WHEREAS, the City Manager recommends the establishment of the Economic Development and Marketing Department to provide the necessary resources to move economic development and marketing initiatives forward for the City of Fort Morgan in line with policies set by the City Council; and


WHEREAS, the establishment of this department is in the best interests of furtherance of the City's goals and objectives; and

WHEREAS, the City Charter, at Article V, Section 4(g), establishes the procedure for the creation of departments with the recommendation of such creation and/or consolidation from the City Manager and final approval by ordinance from the City Council;

NOW, THEREFORE, LET IT BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. That the Economic Development and Marketing Department is hereby established and the City Manager is given charge to develop a budget, positions within the organizational structure, and the purpose of the department in line with policies set by the City Council.


