

## RESOLUTION NO. 2016-02-04

### DELEGATING THE CITY COUNCIL'S AUTHORITY TO APPLY FOR A LIQUOR LICENSE ON BEHALF OF THE CITY OF FORT MORGAN TO THE MAYOR AND THE GOLF COURSE MANAGER AT THE FORT MORGAN GOLF COURSE

**WHEREAS**, the City of Fort Morgan may apply for a liquor license to the State Liquor Licensing Authority pursuant to C.R. S. § 12-47-304(1)(a); and,

**WHEREAS**, the application for such license shall include the name and address of the applicant, and if a corporation, also the names and addresses of the president, vice-president, secretary, and managing officer; and,

**WHEREAS**, City staff has made a recommendation that the City obtain a tavern liquor license for the premises of the Quail Dunes Golf Course; and,

**WHEREAS**, the City Council of the City of Fort Morgan, Colorado, desires to delegate the authority to apply for a liquor license to Ronald Shaver, Mayor, as the applicant and Ty Hamer, Golf Course Superintendent, as the manager.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

1. The Council hereby delegates to Ronald Shaver, Mayor, as the applicant and Ty Hamer, Golf Course Superintendent, as the manager, the authority to apply for a liquor license on behalf of the City of Fort Morgan for a tavern liquor license at the Quail Dunes Golf Course.
