AUTHORIZING THE MAYOR TO EXECUTE THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF FORT MORGAN AND ROCKY MOUNTAIN OFFENDER MANAGEMENT SYSTEMS (RMOMS). CONCERNING PROBATION SERVICES

WHEREAS the City of Fort Morgan operates a municipal court of record pursuant to applicable state law; and,

WHEREAS the Municipal Judge may impose supervised probation as a term of a conviction or plea agreement; and,

WHEREAS the City has considered opportunities to administer the supervised probation in an efficient, effective, and economical manner; and,

WHEREAS Rocky Mountain Offender Management Systems (RMOMS) provides supervised probation services, and is willing to contract with the City to provide such services; and,

WHEREAS the City and Rocky Mountain Offender Management Systems (RMOMS) have agreed to the terms contained in the Memorandum of Understanding between the City of Fort Morgan and RMOMS for Probation Supervision and Technology Services for Municipal Court as shown in the attached exhibit.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Sec. 1: The Mayor is hereby authorized to execute the **Memorandum of Understanding between the City of Fort Morgan and Rocky Mountain Offender Management Systems (RMOMS) Inc. for Probation Supervision and Technology Services for Municipal Court.**
