

RESOLUTION NO. 2016-05-04

AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH MORGAN COUNTY SCHOOL DISTRICT RE-3 FOR THE TEMPORARY USE OF PROPERTY LOCATED AT LEGION PARK

WHEREAS, Morgan County School District RE-3 ("School District") is desirous to utilize property, also known as Legion Park, managed by the City for high school baseball programming; and,

WHEREAS, the City of Fort Morgan ("City") operates and manages Legion Park subject to a trust agreement and limitations within the Fort Morgan Municipal Code; and,

WHEREAS, the City is currently in the process finalizing the receipt of full title to the Legion Park property at which time Parties intend to execute a permanent agreement for the use and management of the property; and,

WHEREAS, the School District has required immediate use of the property for various athletic and/or extracurricular programs.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Sec. 1: The Mayor is hereby authorized to execute the **TEMPORARY USE AGREEMENT BETWEEN THE CITY OF FORT MORGAN AND MORGAN COUNTY SCHOOL DISTRICT RE-3 FOR THE USE OF PROPERTY LOCATED AT LEGION PARK** attached hereto as Exhibit A.
