

RESOLUTION NO. 2016-03-05

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A GRANT AGREEMENT FROM THE COLORADO DEPARTMENT OF LOCAL AFFAIRS FOR PARTIAL FUNDING OF A BI-FUEL CNG PICKUP TRUCK

WHEREAS, the Water Department will be adding a Bi-fuel CNG Truck (“CNG Truck”) to its fleet this year; and,

WHEREAS, the acquisition of the CNG Truck will result in lower fuel costs to the department over time; and,

WHEREAS, the City of Fort Morgan (“City”) previously submitted an application to the Colorado Department of Local Affairs (“DOLA”) requesting partial funding for the acquisition of a CNG truck; and,

WHEREAS, DOLA approved the aforementioned application on February 26, 2016; and,

WHEREAS, DOLA will be presenting the City with a Grant Agreement in the amount of \$13,000 for partial funding of the CNG truck; and,

WHEREAS, DOLA requires the Grant Agreement to be fully executed before the funds can be allocated; and,

WHEREAS, City staff has recommended that the City proceed with the execution of the Grant Agreement for the acquisition of the CNG Truck.

NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. The City of Fort Morgan hereby authorizes the Mayor to sign the Grant Agreement between DOLA and the City of Fort Morgan to provide partial funding for the procurement of a CNG Truck.
