

## RESOLUTION NO. 2015-03-06

### DELEGATING THE CITY COUNCIL'S AUTHORITY TO APPLY FOR A LIQUOR LICENSE ON BEHALF OF THE CITY OF FORT MORGAN TO THE MAYOR AND THE GOLF COURSE SUPERINTENDENT AT THE FORT MORGAN GOLF COURSE

**WHEREAS**, the City of Fort Morgan may apply for a liquor license to the State Liquor Licensing Authority pursuant to C.R.S. § 12-47-304(1)(a); and,

**WHEREAS**, the application for such license shall include the name and address of the applicant, and if a corporation, also the names and addresses of the president, vice-president, secretary, and managing officer; and,

**WHEREAS**, City staff has made a recommendation that the City obtain a liquor license on the premises of the Quail Dunes at Fort Morgan Municipal Golf Course; and,

**WHEREAS**, the City Council of the City of Fort Morgan, Colorado, desires to delegate the authority to apply for a liquor license to the Mayor (who is currently Ronald Shaver) as the applicant and to the Golf Course Superintendent (who is currently Ty Hamer) as the manager; and,

**WHEREAS**, City Council desires that future licenses be obtained and/or renewed administratively without additional resolutions upon changing the applicants' names or license type that is appropriate for the operations of the Golf Course.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

1. The Council hereby delegates to the Office of Mayor (currently Ronald Shaver) as the applicant and to the Office of Golf Course Superintendent (currently Ty Hamer) as the manager, the authority to apply for and renew a liquor license on behalf of the City of Fort Morgan at the Quail Dunes at Fort Morgan Municipal Golf Course, until such time as the authority is revoked or modified by the City Council.
