

## ORDINANCE NO. 1182

### AN ORDINANCE CHANGING THE ZONING DESIGNATION OF LANDS IN THE CITY OF FORT MORGAN, COLORADO, FROM URBAN AGRICULTURE (UA) TO MOBILE HOME RESIDENTIAL (R-4) AND FOR SAID PURPOSE AMENDING THE ZONING CODE AND THE OFFICIAL ZONING DISTRICT MAP OF THE CITY OF FORT MORGAN, COLORADO

**WHEREAS**, Ron Greene (the "Owner") has submitted an application in accordance with the City of Fort Morgan Land Use Code to change the zoning designation of property located at 1509 Barlow Road, legally described as Section 32 Township 4 Range 57 PARC S1/2 N OF I-76 (DESC AS PARC C) LSP1601246 EX DEDICATED EASEMENT & EX 2.45A S OF EASEMENT AKA SOUTH PLATTE ANNEX, in the City of Fort Morgan, Morgan County Colorado (the "Property"),

**WHEREAS**, the City of Fort Morgan Planning and Zoning Commission considered the zoning proposal at a duly noticed public meeting held on June 13, 2016, and subsequently forwarded its favorable recommendation to City Council; and

**WHEREAS**, the City Council provided notice of the public hearing on said zoning by publication as provided by law; and,

**WHEREAS**, public notice has been properly given of such proposed zoning of the Property by publication, in The Fort Morgan Times, a newspaper of general circulation within the City of Fort Morgan, by posting of said Property and by mail notification of adjacent property owners in accordance with the applicable provisions of the City of Fort Morgan Land Use Code, Sec. 20-3-40; and,

**WHEREAS**, in accordance with the City of Fort Morgan Land Use Code, Sec. 20-3-40, a public hearing was held before the City Council on June 21, 2016 at 110 Main Street, Fort Morgan, Colorado at which time evidence and testimony were presented to the City Council concerning said zoning proposal; and

**WHEREAS**, the administrative record for this case includes, but is not limited to, the City of Fort Morgan Land Use Code, City of Fort Morgan Comprehensive Plan, and all other applicable ordinances, resolutions and regulations, together with all City of Fort Morgan land use application processing policies that relate to the subject matter of the public hearing, reports, studies and all other submittals of the Owner, any evidence or correspondence submitted by members of the public at the public hearing, and the staff files and reports of the City pertaining to this application; and

**WHEREAS**, City Council has determined that the proposed zoning of the Property, subject to the conditions set forth herein, furthers the public health, safety,

convenience and general welfare of the community; generally conforms with the City's Comprehensive Plan, as amended and updated; is compatible with surrounding uses; and otherwise meets the applicable criteria set forth in the City of Fort Morgan Land Use Code.

**WHEREAS**, no protests were received by the City pursuant to C.R.S. §31-23-305; and,

**WHEREAS**, the Owner of the Property has requested the property to be rezoned from **UA: Urban Agriculture** to **R-4: Mobile Home Residential**; and,

**WHEREAS**, the zoning classification for Mobile Home Residential use is consistent with the City's plan for the area.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF FORT MORGAN,**

**Section 1.** Recitals Incorporated. The recitals contained above are incorporated herein by reference and are adopted as findings and determinations of the City Council.

**Section 2.** That certain property known as 1509 Barlow Road, in the City of Fort Morgan, Morgan County, Colorado, is hereby zoned into **R-4: Mobile Home Residential** as permitted and that the Zoning District Map of the City of Fort Morgan, Colorado, be amended accordingly.
