

RESOLUTION No. 2016-10-02

ACCEPTING A CONTRACT WITH THE COLORADO DEPARTMENT OF TRANSPORTATION FOR STATE HIGHWAY MAINTENANCE

WHEREAS, the City of Fort Morgan has multiple Colorado State Highways that traverse the City's incorporated area; and,

WHEREAS, Colorado Revised Statutes § 29-1-203 authorize the City of Fort Morgan and the State of Colorado to enter into agreements to provide for the maintenance of state highways within the City; and,

WHEREAS, the City of Fort Morgan has negotiated a rate of \$625.00 per lane mile to provide maintenance of state highways within the City of Fort Morgan; and,

WHEREAS, the City currently has about 18.12 lane miles of state highway within City limits, which equates to \$11,325.00 per year to provide maintenance on behalf of the State of Colorado; and,

WHEREAS, the City and Colorado Department of Transportation have memorialized the understanding in the attached contract.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1: The City Council of the City of Fort Morgan hereby authorizes the Mayor to execute the Contract with the State of Colorado acting by and through the Department of Transportation.

Section 1: The City Council of the City of Fort Morgan hereby authorizes the City Manager or his designee to perform the work contemplated by the Contract.
