

RESOLUTION No. 2011-04-02

DELEGATING THE CITY COUNCIL'S AUTHORITY TO APPLY FOR A LIQUOR LICENSE ON BEHALF OF THE CITY OF FORT MORGAN TO THE MAYOR AND THE GOLF COURSE MANAGER FOR THE SALE OF 3.2 BEER AT THE FORT MORGAN GOLF COURSE

WHEREAS, the City of Fort Morgan, a municipal corporation, may apply for a liquor license to the State Liquor Licensing Authority pursuant to 12-47-304(1)(a), C.R.S.; and,

WHEREAS, the application for such license shall include the name and address of the applicant, and if a corporation, also the names and addresses of the president, vice president, secretary and managing officer; and,

WHEREAS, City staff has made a recommendation that the City obtain a license for the sale of 3.2 Beer on the premises of the Fort Morgan Golf Course; and,

WHEREAS, the City Council of the City of Fort Morgan, Colorado, desires to delegate the authority to apply for said liquor license to the Mayor and the Golf Course Manager as co-applicants.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

1. The Council hereby delegates to the Mayor, a position held at the time of passage of this resolution by Terry L. McAlister, and the Golf Course Manager, a position held at the time of passage by Tyler Tarpley, as co-applicants, the authority to apply for a liquor license on behalf of the City of Fort Morgan for the sale of 3.2 Beer at the Fort Morgan Golf Course.
