

## ORDINANCE NO. 1112

### AN ORDINANCE DECOMMISSIONING THE CITY DEPARTMENT OF MARKETING AND ECONOMIC DEVELOPMENT

**WHEREAS**, the City of Fort Morgan had previously undertaken a review of the various needs of the departments within the City organization; and,

**WHEREAS**, on or about September 21, 2010, the City Manager recommended the creation of the Marketing and Economic Development Department; and,

**WHEREAS**, this department was created on or about October 5, 2010; and,

**WHEREAS**, after evaluation of the overall City budget, the Acting City Manager and Marketing Director now recommend that under the current budget circumstances, the creation of such department was not the most efficient means at this time to further the City's goals and objectives in this area; and,

**WHEREAS**, the City Charter, at Article V, Section 4(g) establishes the procedure for the abolition of departments with the recommendation of such abolition from the City Manager and final approval by ordinance from the City Council.

**NOW, THEREFORE, LET IT BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1.** The Department of Marketing and Economic Development is hereby abolished and will be decommissioned in furtherance of the goals and objectives of the City Council through the most fiscally responsible and efficient means available to the City of Fort Morgan.
