Andrea -

I am hereby requesting copies of the two severance agreements with former city manager Michael Nagy that were discussed and referred to by Fort Morgan City Attorney Jeff Wells at the regular meeting of the Fort Morgan City Council on March 4.

Wells referred to one of the documents as the "resignation agreement," which was ultimately approved by the council, and the other as the "termination agreement." I am particularly interested in the press release that Wells indicated was attached as an exhibit to the resignation agreement.

Having been discussed and referred to in a public meeting of the council, these documents are public records under the Colorado Open Records Act.

While it is not required under the Act that I state a reason for my request to see these documents, you asked that I include that reason. The documents are of public interest to Fort Morgan residents, and are essential to the newspaper's ability to accurately and clearly report the actions of the council in this matter.

As to a deadline for fulfilling this request, I would like them as soon as possible — a story on the approval of the resignation agreement is planned for today's paper, and I would need them no later than 10 a.m. to be useful in preparing that story.
