

## **RESOLUTION NO. 2013-07-02**

### **RESOLUTION ADJUSTING THE ELECTRIC RATES FOR THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN**

**WHEREAS**, it has been recommended by the City's consultants, McFadden Consulting Group, Inc., that the Residential, Small Commercial General and Municipal Rate be adjusted as follows: that the Consumer Charge be increased from \$4.9724 to \$5.12 and that the Energy Charge be increased from \$.0676 to \$.0743; and,

**WHEREAS**, it has also been recommended that Commercial Demand Meters, Larger Commercial, and Irrigation rates be adjusted as follows: that the Demand Charge be increased from \$9.7589 to \$10.2159 and that the Energy Charge be increased from \$.0623 to \$.0684; and,

**WHEREAS**, it has also been recommended that Transmission rates be adjusted as follows: that the Demand Charge be increased from \$9.6887 to \$10.1431 and that the Energy Charge be increased from \$.0601 to \$.0662; and,

**WHEREAS**, it has also been recommended that Residential Demand rates be adjusted as follows: that the Demand Charge be increased from \$9.7589 to \$10.2159 and that the Energy Charge be increased from \$.0623 to \$.0684; and,

**WHEREAS**, it has also been recommended that Interruptible Load Management Service rates be adjusted as follows: that the Demand Charge be increased from \$9.6887 to \$10.1431 and that the Energy Charge be increased from \$.0623 to \$.0684; and,

**WHEREAS**, pursuant to Sec. 16-1-50, *Code of the City of Fort Morgan*, "[c]harges for the supply of electric. . . service[s] shall be, from time to time, established by resolution of the City Council"; and,

**WHEREAS**, the "Sixth Revised" Sheet No. 15 and 16 (of the published tariff of electric rates of the City of Fort Morgan, Colorado incorporated herein by this reference) shall be effective July 1, 2013.

**NOW, THEREFORE, BE IT RESOLVED BY BOARD OF THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1** Effective July 1, 2013, for all utility bills generated on or after such date, the City hereby adopts the Electric Rates (attached hereto as Exhibit A).
