

ORDINANCE NO. 1141

AN ORDINANCE AMENDING THE APPROPRIATION OF MONIES FOR THE FUNDS OF THE CITY OF FORT MORGAN, COLORADO

UPON AND PURSUANT to the revised estimate of the probable revenue and expenses submitted to the City Council of the City of Fort Morgan, Colorado, and upon a budget made by said Council, and for the purpose of raising funds to defray all expenses of conducting the business of the government of the City and payment of all liabilities of the City falling due or accruing during the fiscal year ending December 31, 2012; and,

WHEREAS, the 2012 budget was amended in December of 2012 by Ordinance 1133 of the City of Fort Morgan to account for unforeseen circumstances that occurred in 2012; and;

WHEREAS, pursuant to the City's independent audit of the 2012 expenditures, further adjustments to the 2012 budget are required to ensure compliance with applicable laws and accounting practices; and,

WHEREAS, 2012 budget adjustments may be made by ordinance up until the finalization of the 2012 audit.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Of the monies arising from electric, water, gas, sewer, and sanitation charges, taxes, fines, licenses and all other sources of monies of the City of Fort Morgan, the appropriation to the several funds of said City for the purposes of operations, debt service and capital outlays is amended as follows and attached hereto and incorporated herein by reference:
