

RESOLUTION No. 2014-02-02

AUTHORIZING THE MAYOR TO SIGN AN AGREEMENT BETWEEN THE CITY OF FORT MORGAN, EAGLE-NET ALLIANCE, MORGAN COUNTY, AND MORGAN COUNTY SCHOOL DISTRICT RE-3 FOR A TEMPORARY FIBER NETWORK CONNECTION

WHEREAS, EAGLE-Net operates a fiber optic broadband communications network in and throughout Colorado for the purpose of providing broadband services to local governments, school districts, libraries and other similar entities; and

WHEREAS, EAGLE-Net has contracted to provide internet services with Morgan County and Morgan County School District RE-3; and,

WHEREAS, the County and School District have an immediate need to connect to EAGLE-Net, but do not have an efficient or economic way to connect to the provider; and,

WHEREAS, the City owns, operates, and maintains a fiber network; and,

WHEREAS, the City has a fiber optic line that runs within close proximity to existing EAGLE-Net infrastructure; and,

WHEREAS, such line has limited excess capacity that could be utilized on a temporary basis; and,

WHEREAS, such line is utilized solely for security purposes for the City's electric department substation; and,

WHEREAS, there is a pressing need to ensure high speed internet that is cost effective to the County and School District; and,

WHEREAS, a temporary connection will allow access to internet services for the County and School District while allowing EAGLE-Net to prepare a permanent connection; and,

WHEREAS, a proposed Agreement for temporary connection has been prepared and is attached hereto and incorporated by this reference.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Sec. 1: The Mayor is hereby authorized to sign the TEMPORARY FIBER OPTIC CABLE ATTACHMENT AGREEMENT BETWEEN THE CITY OF FORT MORGAN, MORGAN COUNTY, MORGAN COUNTY SCHOOL DISTRICT RE-3, AND THE EAGLE-NET ALLIANCE.
