

## ORDINANCE NO. 1184

### AN ORDINANCE COMBINING THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO, AND THE FORT MORGAN FIBER UTILITY

**WHEREAS**, the City of Fort Morgan owns and operates several utilities as enterprise funds, including the Electric Department and System Enterprise of the City of Fort Morgan (hereafter "Electric Fund") and the Fort Morgan Fiber Utility; and,

**WHEREAS**, the City of Fort Morgan is consistently looking for opportunities to provide more efficient and effective services to the community through various improvements to operational efficiencies; and,

**WHEREAS**, the City of Fort Morgan has determined that it will be more efficient to combine the Fort Morgan Fiber Utility into the Electric Fund as a department of the Electric Fund; and

**WHEREAS**, the combining of departments requires action by an Ordinance pursuant to Article V Sec. 4(g) of the Fort Morgan Charter.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY  
OF FORT MORGAN,**


**Section 1.** The Fort Morgan Fiber Utility is hereby combined into the Electric Department and System Enterprise of the City of Fort Morgan as a department therein.

**Section 2.** The City Manager, and/or his or her designee, is directed to combine the assets and accounting for the consolidation of the Fiber Utility into the Electric Fund.
