

RESOLUTION NO. 2017-04-06

NAMING THE TRAINING ROOM IN THE FORT MORGAN POLICE DEPARTMENT BUILDING IN HONOR OF FALLEN POLICE OFFICERS

WHEREAS, the City Council has been granted broad authority to provide for the establishment, maintenance, and public improvements, public works, public utilities, public services, and public buildings of every nature pursuant to the Fort Morgan Charter Article IV Section 4; and

WHEREAS, the City Council desires to honor Marshal Charles P. Eyser and Officer Fred Rehmer, law enforcement officers who served and protected the City of Fort Morgan, its citizens, and surrounding community wherein they died in the line of duty; and,

WHEREAS, Marshal Charles P. Eyser was killed in the line of duty on September 30, 1916, during the investigation of a supply of illegal alcohol when he was fatally shot through the heart; and,

WHEREAS, Officer Fred Rehmer was responding to a call concerning a deadly weapon being used in an assault when his patrol vehicle was forced off the roadway into a tree resulting in his death on December 18, 1982; and,

WHEREAS, the City Council desires to rename and designate the training room at the Fort Morgan Police Department as the "Eyser-Rehmer Memorial Training Room" in order to memorialize the sacrifices made by these officers and their families.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1: City Council hereby names the training room at the Fort Morgan Police Department the "Eyser-Rehmer Memorial Training Room."
