

ORDINANCE NO. 1201-G

AN ORDINANCE ADJUSTING THE GAS RATES OF THE NATURAL GAS DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN

WHEREAS, it is necessary from time to time to adjust the rates for the Natural Gas Department and System Enterprise of the City of Fort Morgan; and,

WHEREAS, pursuant to Sec. 16-1-50, *Code of the City of Fort Morgan*, “[c]harges for the supply of electric and gas service[s] shall be, from time to time, established by resolution of the City Council”; and,

WHEREAS, the gas rates include three components including the Meter & Billing, Delivery Charge, and Gas Supply Charge; and,

WHEREAS, the City of Fort Morgan Gas Tariff Number 3, which provides the policies and procedures for the calculation of gas rates, allows for changes to the Gas Supply Charge by resolution, but other changes require additional notice; and,

WHEREAS, it has been recommended by the City's consultants, McFadden Consulting Group Inc., that the Delivery and Gas Supply Charge portions of the rates be adjusted; and,

WHEREAS, the “Eighth Revised” Sheet No. 10 (of the published tariff of gas rates of the City of Fort Morgan, Colorado incorporated herein by this reference) shall be effective December 1, 2017.

NOW, THEREFORE, BE IT RESOLVED BY BOARD OF THE NATURAL GAS DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1 Effective December 1, 2017, for all utility bills generated on or after such date, the City hereby adopts the Gas Rates (attached hereto as Exhibit A) which reflects the following changes:
