

## ORDINANCE NO. 1215

### AN ORDINANCE AMENDING CHAPTER 21 ARTICLE 4 OF THE FORT MORGAN MUNICIPAL CODE CONCERNING THE ENERGY CODE

**WHEREAS**, the City of Fort Morgan previously adopted ordinance 1187 which, in part, set the date for the City to begin enforcement of the 2015 International Energy Conservation Code (IECC) as January 1, 2018; and

**WHEREAS**, the City of Fort Morgan subsequently adopted ordinance 1198 which, in part, postponed date for the City to begin enforcement of the 2015 IECC to July 1, 2018; and

**WHEREAS**, City staff has been unable to finish vetting the imposition of door blower testing and other ramifications of the 2015 IECC as anticipated; and

**WHEREAS**, the pending enforcement date for the IECC should be extended to allow proper vetting of the requirements, its ramifications and allow for additional notice to be provided to contractors.

### NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF FORT MORGAN,

**Section 1.** The Fort Morgan Municipal Code Chapter 21, Article 11 Section 10 is hereby amended as reflected below:

#### **Sec. 21-11-10. - Adoption.**

That certain document, a copy of which is on file in the office of the City Manager, being marked and designated as the International Energy Conservation Code, 2015 edition, which will be fully enforced July 1, 20189. This Code does not include any of the Appendix, as published by the International Code Council, and is hereby adopted as the Energy Conservation Code of the City for regulating and governing energy efficient building envelopes and installation of energy efficient mechanical, lighting and power systems as herein provided; providing for the issuance of permits and collection of fees therefor; and each and all of the regulations, provisions, penalties, conditions and terms of said Energy Conservation Code on file in the office of the City Manager are hereby referred to, adopted and made a part hereof as if fully set out in this Article.


