

RESOLUTION NO. 20108-10-02

RESOLUTION ADJUSTING THE GAS RATES OF THE GAS DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN

WHEREAS, it has been recommended by the City's consultants, McFadden Consulting Group, Inc., that the Residential Service Rate (Schedule RS) be adjusted as follows: that the Commodity Charge be increased from \$.47686 to \$.5590; and,

WHEREAS, it has also been recommended that Commercial Service Rate (Schedule CS) be adjusted as follows: that the Commodity Charge be increased from \$.47686 to \$.5590; and,

WHEREAS, it has also been recommended that Municipal Service Rate (Schedule MS) be adjusted as follows: that the Commodity Charge be increased from \$.47686 to \$.5590; and,

WHEREAS, pursuant to Sec. 16-1-50, *Code of the City of Fort Morgan*, "Charges for the supply of electric and gas service shall be, from time to time, established by resolution of the City Council"; and,

WHEREAS, the "Ninth Revised" Sheet No. 10 (of the published tariff of gas rates of the City of Fort Morgan, Colorado incorporated herein by this reference) shall be effective October 1, 2018.

NOW, THEREFORE, BE IT RESOLVED BY BOARD OF THE GAS DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1 Effective October 1, 2018, for all utility bills generated on or after such date, the City hereby adopts the Gas Rates (attached hereto as Exhibit A).
