

# **RESOLUTION NO. 2019-05-02**

## **RESOLUTION AMENDING THE 2019 SCHEDULE OF FEES**

**WHEREAS**, the City of Fort Morgan relies upon fees to provide many services to customers and citizens; and,

**WHEREAS**, fees associated with the services provided by the City require adjustment from time to time to account for the increase in the costs to provide such services and to comply with changing regulations; and,

**WHEREAS**, the City Council has adopted the Schedule of Fees as a part of the 2019 budget process through Resolution No. 2018-10-03 on October 16, 2018; and,

**WHEREAS**, since the adoption of the 2019 Schedule of Fees, the Fort Morgan Police Department and City staff have determined that an amendment is required to ensure proper cost recovery for the services provided when responding to criminal justice records requests, consistent with state law; and,

**WHEREAS**, also since the adoption of the 2019 Schedule of Fees, the Fort Morgan Municipal Airport Advisory Board and the Public Works Director have determined that an airport lease fee is appropriate to adopt within the Schedule of Fees; and,

**WHEREAS**, the Amended 2019 Schedule of Fees is attached hereto and incorporated herein as Exhibit A.

### **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1** This resolution and accompanying Schedule of Fees is intended to supersede all previous fee schedules adopted by the City Council.

**SECTION 2** Effective upon approval, the City hereby adopts the amended 2019 Schedule of Fees (attached hereto as Exhibit A).


