

## **RESOLUTION NO. 2019 – 07- 01**

### **A RESOLUTION AUTHORIZING THE MAYOR TO SIGN A GRANT AGREEMENT WITH THE FEDERAL AVIATION ADMINISTRATION**

**WHEREAS**, the Federal Aviation Administration (“FAA”) provides funding for airport project designs and construction; and,

**WHEREAS**, the City of Fort Morgan owns and operates the Fort Morgan Municipal Airport; and,

**WHEREAS**, the City of Fort Morgan has included rehabilitation and possible expansion of the apron adjacent to the FBO office as a part of the City’s Master Plan for the airport; and,

**WHEREAS**, the FAA is willing to fund approximately 90% of the total cost of the project (\$900,000), and the Colorado Department of Transportation (“CDOT”) is willing provide funding for about 5% (\$50,000) of the project cost; and,

**WHEREAS**, the City Council similarly authorized the Mayor to sign grant agreements with the FAA and/or CDOT of the design and reconstruction of the airport last September, and

**WHEREAS**, reimbursement will require an agreement or agreements between the FAA, Colorado Department of Transportation and the City of Fort Morgan which is currently being finalized.

**NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1.** The Mayor is hereby authorized to sign Grant Agreements with the FAA and/or CDOT for the design and reconstruction of the airport apron, and any other related and required agreements and documents with the FAA and/or CDOT.


