

RESOLUTION No. 2019-08-03

AUTHORIZING THE CITY STAFF TO APPLY FOR A GRANT TO ASSIST WITH THE 2020 CENSUS COMPLETE COUNT CAMPAIGN

WHEREAS, the City of Fort Morgan has the opportunity to participate in grant funding provided by The Colorado Department of Local Affairs (“DOLA”) to assist with the 2020 Census Complete Count campaign; and,

WHEREAS, the City of Fort Morgan supports the City’s grant application to assist with the 2020 Census Complete Count effort and to supplement City staff’s ongoing efforts to ensure that all its residents are represented and participate in the 2020 census, and that the City is eligible for all applicable resources, benefits, representation, monies and/or credits that may be available based upon population and the 2020 Census numbers; and,

WHEREAS, the City of Fort Morgan has evaluated the circumstances and concluded that it is able to accept these Colorado state general fund monies if granted; and,

WHEREAS, the City of Fort Morgan intends to apply for a grant with DOLA to assist with the 2020 Census Complete Count efforts within the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

- Section 1:** The City Council of the City of Fort Morgan strongly supports the application for a DOLA grant to assist with the 2020 Census Complete Count campaign.
- Section 2:** If the grant is awarded, the City Council of the City of Fort Morgan strongly supports the acceptance of the state funds to facilitate and assist the City’s 2020 Census Complete Count efforts.
- Section 3:** The City Council of the City of Fort Morgan authorizes the expenditure of funds necessary to meet the terms and obligations of any Grant awarded.
- Section 4:** If the grant is awarded, the City Council of the City of Fort Morgan hereby authorizes the Mayor to sign the grant agreement with the Colorado Department of Local Affairs, or its designated entity per the Grant agreement, and any other related documents requiring a signature and/or authorization.
- Section 5:** This resolution is to be in full force and effect from and after its passage and approval.
