

## **RESOLUTION NO. 2019-08-04**

### **RESOLUTION AMENDING THE 2019 SCHEDULE OF FEES**

**WHEREAS**, the City of Fort Morgan relies upon fees to provide many services to customers and citizens; and,

**WHEREAS**, fees associated with the services provided by the City require adjustment from time to time to account for the increase in the costs to provide such services; and,

**WHEREAS**, the City Council has adopted the Schedule of Fees as a part of the 2019 budget process through Resolution No. 2018-10-03 on October 16, 2018, and amended the fees through Resolution No. 2019-05-02 on May 7, 2019; and,

**WHEREAS**, since the most recent amendment to the 2019 Schedule of Fees, the Fort Morgan Police Department requests an increased fee for a Certified VIN inspection, which the State recently increased and authorized; and,

**WHEREAS**, also since the most recent amendment to the 2019 Schedule of Fees, the City entered into a new contract with Union Colony for its armed security services for Municipal Court which increased their hourly rate for such services and which necessitates an increase in court security fees assessed on cases requiring a court appearance; and,

**WHEREAS**, also since the most recent amendment to the 2019 Schedule of Fees, the surcharge required by the State to be collected by the Municipal Court for the Brain Injury Trust Fund has changed pursuant to HB 19-1147; and

**WHEREAS**, also since the most recent amendment to the 2019 Schedule of Fees, the City Finance Department has determined that certain charges regarding utility shut-offs did not adequately contribute to the administrative and staff costs and had not been updated to reflect the increase in costs to provide such services for a long period of time; and,

**WHEREAS**, the pertinent amendments and updates to 2019 Schedule of Fees are attached hereto and incorporated herein as Exhibit A, and the remaining sections of the 2019 Schedule of Fees, as amended in May 2019, remain the same.

### **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1** This resolution and accompanying amendments to Schedule of Fees are intended to be reflected in the amended 2019 Schedule of Fees, which shall supersede all previous fee schedules adopted by the City Council.

**SECTION 2** Effective upon approval, the City hereby adopts the amendments and updates to the 2019 Schedule of Fees (amendments attached hereto as Exhibit A).
