

RESOLUTION NO. 2019-10-02

RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH THE MORGAN COUNTY QUALITY WATER DISTRICT RELATED TO THE JENSEN ONION PROPERTY

WHEREAS, Colorado Revised Statutes §29-1-203 authorizes intergovernmental agreements by governments and political subdivisions within the State to provide and share the costs of functions or services; and,

WHEREAS the City of Fort Morgan (“City”) owns and operates a municipal water utility system furnishing water service to the public in and around the City; and,

WHEREAS the Morgan County Quality Water District (“District”) owns and operates a public water utility system and furnishes water service to the public in the areas surrounding the City; and,

WHEREAS the properties identified in the intergovernmental agreement, attached hereto as “Exhibit A,” are located within the District’s service area and outside of the City’s boundaries; and,

WHEREAS although the District is entitled to provide water service to those properties, the City previously provided water taps to the owner of said properties, and the owner would like to utilize the same on these properties; and

WHEREAS based on the unique circumstances described within the attached intergovernmental agreement, the City and the District desire to enter into this agreement whereby the City will provide potable water to the identified properties with the previously purchased taps; and,

WHEREAS, the City Council therefore authorizes the City to enter into a water supply agreement with the District, as set forth in “Exhibit A.”

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. The City hereby approves the intergovernmental agreement with the Morgan County Quality Water District related to the Jensen Onion property (attached hereto as Exhibit A) and authorizes the Mayor to sign on the City’s behalf.


