

## **RESOLUTION NO. 2019-10-04**

### **RENAMING OF MUSEUM GALLERIES AS REQUESTED BY THE HERITAGE FOUNDATION**

**WHEREAS**, the City Council has been granted broad authority to provide for the establishment, maintenance, and improvement of public services, public buildings parks, cemeteries, public grounds and public libraries pursuant to the Fort Morgan Charter Article IV Section 4; and

**WHEREAS**, Sue Spencer is a citizen who has dedicated significant amounts of time and energy in support of the community through the Heritage Foundation, which has provided vital support to the Fort Morgan Museum, as president of the Board for 32 years, and as founding member and organizer of numerous fundraisers and activities which helped raise funds to create the library-museum complex, as well as organizer for many exhibits, events and initiatives; and,

**WHEREAS**, Sue Spencer's contributions to the Fort Morgan Museum and Heritage Foundation have been integral to the success and growth of the Museum; and,

**WHEREAS**, the City Council desires to honor Sue Spencer for making these contributions to the community and museum; and

**WHEREAS**, the City Council desires to name and designate the East Gallery at the Fort Morgan Museum as "The Sue Spencer Gallery"; and

**WHEREAS**, Vic Ostermiller is a citizen who has dedicated significant amounts of time and energy in support of the community through the Heritage Foundation, which has provided vital support to the Fort Morgan Museum, as the first President of the Heritage Foundation who helped raise money needed to build the library-museum complex, and as part of the Old Fort committee who worked to find a home for the remarkable arrowhead collection and other relevant artifacts; and,

**WHEREAS**, Vic Ostermiller's contributions to the Fort Morgan Museum and Heritage Foundation have been integral to the success and growth of the Museum; and,

**WHEREAS**, the City Council desires to honor Vic Ostermiller for making these contributions to the community and museum; and

**WHEREAS**, the City Council desires to name and designate the Lower Gallery at the Fort Morgan Museum as "The Vic Ostermiller/Founders Gallery."

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1:** City Council hereby names the East Gallery at the Fort Morgan Museum "The Sue Spencer Gallery."

**SECTION 2:** City Council hereby names the Lower Gallery at the Fort Morgan Museum as "The Vic Ostermiller/Founders Gallery."
