AUTHORIZING THE MAYOR TO EXECUTE THE NORTHERN INTEGRATED SUPPLY PROJECT PHASE I FINANCING AGREEMENT FOR PARTICIPATION IN THE NORTHERN INTEGRATED SUPPLY PROJECT

WHEREAS, the City of Fort Morgan, Colorado is a participant in the Northern Integrated Supply Project (NISP); and,

WHEREAS, NISP is developing a water project (the "Project") for the purpose of developing a new reliable water supply for the beneficial use of the City and other entities; and,

WHEREAS, all costs of the Project will be divided among the City and other entities that participate in the Project; and,

WHEREAS, there are multiple Phases of this Project, and Phase I includes the pre-construction elements and actions for NISP; and,

WHEREAS, the attorneys for each entity have negotiated and agreed upon the terms of the attached Agreement, which relates to financing and funding for Phase I of the Project; and,

WHEREAS, the City wishes to continue pursuing the NISP Project by providing the funding necessary for its completion; and

WHEREAS, the City wishes to execute the NISP Phase I Financing Agreement with the Northern Integrated Supply Project Water Activity Enterprise, a copy of which Agreement is attached hereto and incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:



INTRODUCED, PASSED, APPROVED AND ADOPTED this 3rd day of December 2019, the vote upon roll call being as follows:


