A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE THE FORT MORGAN MUNICIPAL AIRPORT SPORT PARACHUTING LETTER OF AGREEMENT WITH ORANGE SKIES FREE FALL CENTER, LLC

WHEREAS, the City of Fort Morgan (“City”) owns the Fort Morgan Municipal Airport; and

WHEREAS, the City and Orange Skies Free Fall Center, LLC (“Operator”) first entered into an agreement concerning sport parachuting activity at the Fort Morgan Municipal Airport in April 2019; and

WHEREAS, City Staff and the City Attorney have now drafted, negotiated and finalized the subject 2020 Sport Parachuting Agreement between the City and Operator, which is substantially similar to the agreement executed in April 2019; and

WHEREAS, the City and Operator desire to enter into the attached Fort Morgan Municipal Airport Sport Parachuting Letter of Agreement; and,

WHEREAS, the City and Operator have put their understanding into writing in the attached Agreement, attached hereto as Exhibit A, which is incorporated herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1 The City hereby authorizes the Mayor to sign the Fort Morgan Municipal Airport Sport Parachuting Letter of Agreement with Orange Skies Free Fall Center, LLC, regarding sport parachuting activity at the Fort Morgan Municipal Airport.
