

RESOLUTION NO. 2020-04-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO, APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF FORT MORGAN, THE CITY OF BRUSH, AND THE COUNTY OF MORGAN, COLORADO FOR THE OPERATION OF A SPECIAL RESPONSE TEAM BY THE FORT MORGAN POLICE DEPARTMENT

WHEREAS, intergovernmental agreements to provide functions or services, including the sharing of costs of such services or functions by political subdivisions of the State of Colorado, are specifically authorized by Colorado Revised Statutes § 29-1-203; and

WHEREAS, emergencies may arise, in the City of Fort Morgan, the City of Brush or unincorporated Morgan County, which are of such intensity and duration as to place greater demands on those jurisdictions' personnel and equipment than the jurisdiction can handle independently; and

WHEREAS, it is in the best interest of the City of Fort Morgan, as well as its neighboring jurisdictions, to maintain uniform equipment, training, policies, procedures, and personnel standards, pertaining to each other's tactical team members, so that each may have the service of the other jurisdictions to aid and assist it in exceptional instances; and

WHEREAS, it is in the best interests of the City of Fort Morgan to maintain a Special Response Team, staffed and equipped by the law enforcement agencies operated by the City of Fort Morgan, City of Brush, and the Morgan County Sheriff's Office; and

WHEREAS, the City Council therefore desires to approve this intergovernmental agreement with the City of Brush and the County of Morgan for the operation of a special response team by the Fort Morgan Police Department, attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

1. The Fort Morgan City Council incorporates the foregoing recitals as its conclusions, facts, determinations, and findings.
2. The City hereby adopts the Intergovernmental Agreement for the Operation of a Special Response Team by the Fort Morgan Police Department, attached hereto as Exhibit A.
