

## **RESOLUTION NO. 2020-05-01**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO, APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF FORT MORGAN AND THE MORGAN COUNTY SCHOOL DISTRICT Re-3**

**WHEREAS**, intergovernmental agreements to provide functions or services, including the sharing of costs of such services or functions by political subdivisions of the State of Colorado, are specifically authorized by Colorado Revised Statutes § 29-1-203; and

**WHEREAS**, through a federal grant from the Department of Justice, the Morgan County School District Re-3 ("School District") had previously partnered with the City of Fort Morgan ("City") to obtain services of the Fort Morgan Police Department ("Department") to provide a School Resource Officer ("SRO") for schools in the District; and,

**WHEREAS**, despite the lack of current federal funding of this program, the School District and City wish to continue the program through a joint effort by sharing the cost of the SRO Program through an Intergovernmental Agreement; and,

**WHEREAS**, it is in the best interests of the residents of the City of Fort Morgan to maintain this relationship with the School District and share the cost of the SRO Program; and

**WHEREAS**, the City Council therefore desires to approve this intergovernmental agreement with the City of Fort Morgan and the School District, attached hereto as Exhibit A.

### **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

1. The Fort Morgan City Council incorporates the foregoing recitals as its conclusions, facts, determinations, and findings.
2. The City hereby adopts the Intergovernmental Agreement between the City of Fort Morgan and the Morgan County School District Re-3 regarding the School Resource Officer program, attached hereto as Exhibit A.
