

## **RESOLUTION No. 2020-09-03**

### **A RESOLUTION APPROVING THE CITY'S APPLICATION FOR DESIGNATION AS A CERTIFIED LOCAL GOVERNMENT AND AUTHORIZING THE MAYOR'S SIGNATURE ON THE LOCAL GOVERNMENT CERTIFICATION AGREEMENT**

**WHEREAS**, the City of Fort Morgan enacted Ordinance No. 1140 on July 16, 2013, to preserve and protect the City's historic buildings, structures, sites, landscapes and objects; and,

**WHEREAS**, the City of Fort Morgan has established a Historic Preservation Commission of interested and professional citizens to identify, designate, preserve, protect and promote our City's history as exhibited by the historic built environment; and,

**WHEREAS**, the City of Fort Morgan has determined that a system of survey and inventory of the historic built environment is an important tool for future planning; and,

**WHEREAS**, the City of Fort Morgan wishes to foster public participation in its historic preservation activities; and,

**WHEREAS**, the City of Fort Morgan believes that the Certified Local Government Program of the National Park Service and History Colorado provides support and guidance in meeting our local historic preservation goals.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1:** The City shall submit an application for, and requests designation as, a Certified Local Government, and understands the obligations and opportunities of such designation.

**SECTION 2:** The Mayor's signature is authorized and directed on the "Local Government Certification Agreement," which shall be executed pursuant to the provisions of the National Historic Preservation Act, as amended, to applicable federal regulations (36 CFR 61), and to the "Process for Certifications of Local Governments in Colorado."


