

RESOLUTION NO. 2020-12-01

INCREASING THE WASTEWATER RATES FOR THE CITY OF FORT MORGAN, COLORADO

WHEREAS, as a wastewater service provider the City is responsible for the expenses associated with a treatment facility, collection systems and a pump station; and,

WHEREAS, the projected revenues of the wastewater rates were analyzed in a study completed in 2019 by Raftelis Financial Consultants; and,

WHEREAS, the 2019 rate study projects additional increases in fixed costs as well as additional capital improvement projects in the wastewater enterprise; and,

WHEREAS, an increase in the wastewater rates would create additional revenue within the Wastewater Enterprise Fund to allow for future infrastructure improvements, rate stabilization and major expansions that will benefit the customers; and,

WHEREAS, pursuant to Sections 17-5-10 and 18-3-10 of the *Fort Morgan Municipal Code*, all water and wastewater rents, rates and charges payable within the City are to be established by Resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1. Effective January 1, 2021, for all utility bills generated on or after such date, the City hereby adopts the Wastewater Rates attached hereto as Exhibit A.
