

RESOLUTION NO. 2020-12-02

A RESOLUTION APPOINTING LOREN G. SHARP AS CHIEF OF POLICE AND APPROVING AN EMPLOYMENT AGREEMENT IN CONNECTION THEREWITH

WHEREAS, pursuant to Article XI, Section 3 of the Charter of the City of Fort Morgan ("City"), the City Council ("Council") possesses the authority to appoint a Chief of Police; and

WHEREAS, the City Charter prescribes certain powers and responsibilities of a Chief of Police, an office which is currently vacant; and

WHEREAS, the Council finds that it is necessary and desirable to appoint Loren G. Sharp to perform the duties and responsibilities of Fort Morgan Chief of Police and to approve an employment agreement with Sharp in connection therewith.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

1. The Fort Morgan City Council incorporates the foregoing recitals as its conclusions, facts, determinations, and findings.
2. The Fort Morgan City Council hereby appoints Loren G. Sharp as the Fort Morgan Chief of Police.
3. The Employment Agreement, attached hereto as "Exhibit A," and setting forth in more particular the terms and conditions of the appointment made by Section 2 above, is hereby approved, and the Mayor is authorized to sign the agreement on the City's behalf.
4. The appointment made by Section 2 of this Resolution shall become effective on December 15, 2020.
