

## RESOLUTION NO. 2021-06-02

### SETTING THE STORMWATER FEE RATES FOR THE CITY OF FORT MORGAN, COLORADO

**WHEREAS**, the continued development and maintenance of stormwater infrastructure for the City of Fort Morgan is in the best interests of the City; and,

**WHEREAS**, in order to maintain competitive applications for grant funding from the State of Colorado for stormwater projects; and,

**WHEREAS**, the City of Fort Morgan continues to see rises in the costs for stormwater capital improvement projects and the maintenance of stormwater infrastructure; and,

**WHEREAS**, an implementation of the stormwater rates would create additional revenue within the Sewer Enterprise Fund to allow for future infrastructure improvements, maintenance, and expansions that will benefit the City; and,

**WHEREAS**, pursuant to Section 17-8-50 of the *Fort Morgan Municipal Code* stormwater charges payable within the City are to be established by Resolution of the City Council.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

Effective July 1, 2021, for all utility bills generated on or after such date, the City hereby adopts the Stormwater Rates (attached hereto as Exhibit A).


