

RESOLUTION NO. 2021-10-01

SUPPORTING THE GRANT APPLICATION FOR A HISTORIC SURVEY TO UPDATE THE CITY'S LOCAL RESOURCE INVENTORY THROUGH THE COLORADO CERTIFIED LOCAL GOVERNMENT SUBGRANT PROGRAM

WHEREAS, the City of Fort Morgan has the opportunity to participate in grant funding provided by History Colorado as part of its 2022 Certified Local Government General Grant fund designed to promote, plan, develop, and/or educate communities on historic preservation efforts; and

WHEREAS, the City of Fort Morgan supports the Fort Morgan Historic Preservation Board's grant application for History Colorado's Certified Local Government sub-grant, and if the grant is awarded, the City of Fort Morgan supports the completion of the proposed historic building survey project to identify historic resources; and,

WHEREAS, the Fort Morgan Historic Preservation Board proposes to request up to \$25,000 from History Colorado to provide funding for an outside consultant/contractor and any acceptable related expenses to conduct a qualified historic survey inventory; and,

WHEREAS, the proposed grant-funded project follows local planning efforts, fulfills responsibilities as a Certified Local Government (CLG), is a proactive approach for historical planning efforts, and articulates the shared values of Policy ED 2.4 *Increase awareness and education on historic preservation efforts* and Policy LU 1.3 *Encourage the preservation and restoration of older neighborhoods and buildings* as outlined in the City's Comprehensive Plan adopted August 8, 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

- Section 1:** The City Council of the City of Fort Morgan strongly supports the application for a grant made by the Fort Morgan Historic Preservation Board through the History Colorado CLG sub-grant program.
- Section 2:** If the grant is awarded, the City Council of the City of Fort Morgan agrees to enter into a non-negotiable intergovernmental grant agreement with History Colorado that includes the federal requirements for the CLG sub-grant and State of Colorado terms and conditions.
- Section 3:** The City Council of the City of Fort Morgan authorizes the identified local government staff representative to manage the consultant, submit any required deliverables, including three bids/procurement documentation, the consultant resume, the subcontract certification form, kick-off meeting,

and final project report, and any payment requests, and represent the City of Fort Morgan on all matters related to the project.

Section 4: The City Council agrees to comply with reporting deadlines associated with the project in accordance with an agreed upon schedule. Additionally, the City of Fort Morgan agrees to forfeit any funding if the Fort Morgan CLG is not under contract with the selected consultant within 60 days of receipt of a fully executed grant agreement.

Section 5: If the grant or any portion is awarded, the City Council of the City of Fort Morgan hereby authorizes the Mayor to sign the grant agreement with History Colorado.


