

## **RESOLUTION NO. 2022-01-01**

### **A RESOLUTION EVIDENCING THE CITY'S INTENT TO PURCHASE AN OUTDOOR FITNESS COURT AS PART OF THE 2022 NATIONAL FITNESS CAMPAIGN, PENDING THE APPROVAL OF GRANT FUNDING FROM OTHER SOURCES FOR THE LARGER CENTREPOINTE PARK PROJECT**

**WHEREAS**, the City of Fort Morgan (the "City") has submitted a Grant Application to the National Fitness Campaign (NFC) for participation in their 2022 initiative to install and activate outdoor Fitness Courts in 200 cities and schools across the country; and

**WHEREAS**, pending the approval of grant funding from other sources as part of the larger CentrePoint Park Project, the City plans to accept a \$25,000 grant as part of the NFC and, upon receipt of these funds, plans to provide a local match in an amount to be determined; and

**WHEREAS**, the City plans to secure supplemental funding as needed through community sponsors and other grant opportunities to purchase and implement a free-to-the-public outdoor Fitness Court; and

**WHEREAS**, pending the approval of grant funding from other sources as part of the larger CentrePointe Park Project, the City commits to construct and launch the outdoor Fitness Court by the end of the 2022 calendar year;

**WHEREAS**, the City considers the outdoor Fitness Court to be an important wellness ecosystem that encourages healthier communities, the City supports the NFC's 2022 initiative to install outdoor Fitness Courts across the nation, and, as part of this initiative, the City endeavors to be a leader in providing affordable health and wellness opportunities to local communities.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**Section 1:** The City Council strongly supports the City's participation in the National Fitness Campaign and has appropriated matching funds, pending receipt of the National Fitness Campaign grant, to install an outdoor Fitness Court as part of the CentrePointe Park Project.

**Section 2:** If such grant is awarded, the City Council intends to facilitate the prompt installation and launch of the outdoor Fitness Court by the end of the 2022 calendar year to the best of its ability.

**Section 3:** The City Council hereby authorizes the expenditure of any appropriated funds to meet the terms and obligations of such grant.

**Section 4:** If the grant is awarded, the City Council hereby authorizes the Mayor to sign the grant agreement with the National Fitness Campaign.

**Section 5:** This resolution is to be in full force and effect from and after its passage and approval.


