Section 4: Pursuant to Article XI Section 2 of the City of Fort Morgan Charter, Council hereby confirms the appointment of Charles Peters as Municipal Judge.

Section 5: Pursuant to Article XI Section 2 of the City of Fort Morgan Charter, Council hereby confirms the appointment of Kelly Hansen as Deputy Municipal Judge.

Section 6: Council hereby approves the execution, extension, ratification, and/or acknowledges the applicable contracts for appointed officials.


