

## RESOLUTION NO. 2022-04-02

### A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF FORT MORGAN, COLORADO, ADOPTING THE 2022 CITYWIDE FEE SCHEDULE

**WHEREAS**, the City of Fort Morgan, Colorado (the "City") has been duly organized and is validly existing as a home rule city under Article XX, Section 6 of the Colorado Constitution and the City Charter; and

**WHEREAS**, the City imposes a variety of fees for the services it administers, which from time to time require review and revision; and

**WHEREAS**, the City Council finds it desirable, prudent, and in the best interest of the residents of the City to update the identified fees; and

**WHEREAS**, the applicable portion of the amended 2022 Citywide Fee Schedule is attached hereto and incorporated herein as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**Section 1.** The foregoing recitals are hereby incorporated as conclusions, determinations, facts, and findings of the City Council.

**Section 2.** This resolution and the updated 2022 Citywide Fee Schedule are intended to supersede all previous fee schedules adopted by the City Council.

**Section 3.** Effective upon approval, the City hereby adopts the amended 2022 Citywide Fee Schedule, with the applicable updated portions attached hereto as Exhibit A.
