

RESOLUTION NO. 2022-07-01

A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF FORT MORGAN, COLORADO, FORMALIZING THE CITY'S DECISION TO OPT OUT OF THE PAID FAMILY AND MEDICAL LEAVE INSURANCE ("FAMLI") PROGRAM

WHEREAS, the City of Fort Morgan, Colorado (the "City") has been duly organized and is validly existing as a home rule city under Article XX, Section 6 of the Colorado Constitution and the City Charter;

WHEREAS, in November 2020, Colorado voters approved Proposition 118, which instructed the Colorado Department of Labor and Employment to establish the Paid Family and Medical Leave Insurance ("FAMLI") program, which allows eligible Colorado employees to receive up to 12 weeks of paid family and medical leave benefits each year, beginning on January 1, 2024;

WHEREAS, to fund the FAMLI program, both employers and employees in Colorado will generally be required to pay a payroll premium, beginning on January 1, 2023;

WHEREAS, pursuant to C.R.S. § 8-13.3-522, a local government may decline participation in the FAMLI program;

WHEREAS, the City already offers competitive paid leaves: 11 holidays, 1 day of personal leave, 5 weeks of paid time off to start – which accrue over time and steadily increase with longevity up to over 7 weeks. The City also provides eligible employees with short-term disability benefits and allows employees to utilize 12 weeks of unpaid leave via the Family Medical Leave Act (FMLA)

WHEREAS, all notice requirements applicable to a local government's decision to opt out of the FAMLI program have been satisfied; and

WHEREAS, the City Council finds it desirable and appropriate, and in the best interest of the general welfare of its residents to opt out of the FAMLI program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1. The foregoing recitals are hereby incorporated as conclusions, determinations, facts, and findings of the City Council.

Section 2. The City of Fort Morgan hereby declines participation in the Colorado Paid Family and Medical Leave program.


