

RESOLUTION NO. 2022-06-03

A RESOLUTION AUTHORIZING THE CREATION OF A PEDESTRIAN MALL AND THE SEMI-PERMANENT CLOSURE TO VEHICULAR TRAFFIC OF BEAVER AVENUE BETWEEN MAIN STREET AND STATE STREET

WHEREAS, the City Council has been granted broad authority to provide for the construction, maintenance, operation, and disposition of public improvements, public works, public utilities, public services, and public buildings of every nature pursuant to the Fort Morgan Charter Article IV Section 4; and,

WHEREAS, pursuant to Colorado Revised Statutes §31-15-702, the governing body of each municipality has the power to “lay out, establish, open, alter, widen, extend, grade, pave, or otherwise improve street, parks, and public grounds and vacate the same and... to regulate the use of same”; and,

WHEREAS, the City desires for a semi-permanent pedestrian mall at Beaver Avenue, between Main Street and State Street, to encourage additional safe outdoor walkable space for citizens, customers and visitors of the City; and,

WHEREAS, in order to do so, the City wishes to close to vehicular traffic at Beaver Avenue, between Main Street and State Street; and,

WHEREAS, a City owned-park encompasses the entire block adjacent to one side of Beaver Avenue between Main Street and State Street, and no businesses or private properties front the other side of Beaver Avenue between Main Street and State Street; and,

WHEREAS, the City Council finds it desirable and prudent, and in the best interest of the general health, safety, and welfare of its residents to authorize the semi-permanent closure of this portion of Beaver Avenue.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1: Effective July 1, 2022, City Council hereby authorizes the establishment of a pedestrian mall and the semi-permanent closure to vehicular traffic of the streets and sidewalks on Beaver Avenue between Main Street and State Street.

SECTION 2: Said closure to vehicular traffic shall be in effect until a subsequent Resolution by City Council authorizes otherwise.

SECTION 3: The City Manager or his designee is hereby authorized to take any further action reasonably necessary or prudent to carry out the effect of this Resolution.

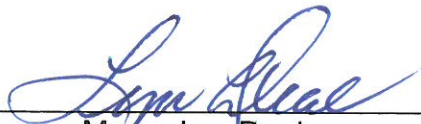
